Every year, a GMB Region is invited to select a recipient to receive the Congress Local Gift award.

This year London Region has chosen the Keech Hospice in Luton who care and support adults and children across Bedfordshire, Hertfordshire, and Milton Keynes with life-limiting conditions to receive the Congress 2025 award.

Keech Hospices are one of a few in the country offering both specialist adult and children's end of life care plus vital support to their families. This organisation was chosen because although hospice care is free for people to use, unlike the NHS, it is not fully state funded.

Keech hospices only receive 30% of all the funding needed from the government and rely on fundraising and the generosity of members of the public.

They extend a huge thank you to GMB members for our donation and wish us well for a successful Congress.



50% of adults in the UK don't have a will and 33% of those are over 55. If you don't have a will you are at risk of everything you have being given to someone you haven't chosen.

If you don't have a power of attorney in place for you or your loved ones and you lose capacity then someone else, who you don't know, could decide what happens to your financial affairs and your health care.

If you don't have a life interest trust in place and the unthinkable happens, your surviving loved ones could be evicted from their homes and your children could lose their inheritance.

Planning for the unthinkable is something many of us avoid doing but it is something that is vitally important to protect you and your loved ones should it happen.

This session will provide important advice about why you should have a will, why you should have a power of attorney and why you should consider a trust. The inconvenience alone coupled with the time and cost consequences of not preparing for the future can have a damaging impact on a family at a time when they are going through so much.

- 72.3% of airport workers have felt unsafe going into work due to abuse or aggressive behaviour from passengers.
- 61% have considered leaving the industry because of the abuse they've faced.
- Only 12% said their health and wellbeing have not been adversely affected by this crisis.



Airport Workers Against Abuse Stand 25

GMB Union launched the "Airport Workers Against Abuse" campaign to tackle the growing issue of abuse faced by airport staff.

This initiative highlights the verbal and physical assaults that employees endure from frustrated passengers, often due to delays, cancellations, or security checks.

The campaign calls for greater public awareness, respect, and support for frontline airport workers, who play a vital role in keeping travel operations smooth and safe.

GMB is urging airport authorities and employers to implement stronger protections, provide better training, and ensure swift action against abusive behaviour.

The union also emphasizes the importance of mental health support for affected workers. By uniting staff across roles—

from check-in and security to baggage handling—the campaign aims to foster solidarity and a zero-tolerance approach to abuse.

GMB's message is clear: abuse is not part of the job, and all airport workers deserve a safe and respectful working environment.

WASPIStand 17

Women Against State Pension Inequality (WASPI) calls for fair compensation on behalf of 3.6 million women born in the 1950s for the way the Department for Work and Pensions communicated changes to their State Pension age from 60 to 65, and later to 66 under the 2011 Pensions Act.

In spring 2024, following a six-year investigation, the Parliamentary and Health Service Ombudsman found the DWP guilty of maladministration and asked MPs to intervene and ensure the Government delivers compensation at Level 4 of their financial remedy scale (£1,000-£2,950) to those affected.

In late 2024, the Government apologised for the mistakes made by the DWP, and accepted the PHSO's finding of maladministration, but nonetheless refused to set up a compensation scheme. In response, WASPI launched a High Court Judicial Review of the Government's decision, arguing the DWP failed to base its conclusions on rational reasons.


