ASDA CONTRACT 6 PROPOSALS

ASDA have started collective consultation with GMB Union on proposals to put all hourly paid colleagues on Contract 6 and pay £9.00 per hour.

This affects all colleagues currently on contract 6 and more than 68,000 employees on 1 to 5.

The first meeting took place with GMB Union on Tuesday 9th April and weekly meetings have been scheduled with GMB Union national reps.

GMB reps and organisers will be asking GMB members to fill out a short Contract 6 & Pay Survey. This will help formulate our Counter Proposals and Pay Claim which we will submit to ASDA during the consultation process.

GMB wants to make sure you have a say on your pay, and the type of contract, you're on.

ASDA Contract 6 Proposals

All hourly paid contracts on Contract 6
£9.00 per hour (1.85% increase)
Differential with NLW 79p per hour
Sainsbury's rate is £9.20 per hour

April 2019 rates

The contract 6 rate - £8.84 per hour (2% increase)
Contracts 1 to 5 (National Living Wage) rate £8.21
per hour (4.9% increase)
Differential 63p per hour

The 2018 rates

The contract 6 rate is £8.67 per hour (2% increase)
Contracts 1 to 5 (National Living Wage) rate £7.83
per hour (4.4% increase)
Differential 84p per hour

Aldi	£9.10 per hour (10.55 in London)

Tesco	£8.42 per hour (£9.10 within M25)

Until now, Contract 6 has been voluntary for existing ASDA colleagues. The ASDA proposals are a departure from this approach and it's important that the collective voice of ASDA colleagues is heard. The best way this can be achieved is through GMB Union.

GMB wants improved pay, job and hours security and collective bargaining for ASDA colleagues. Last year we surveyed members on the ASDA/Sainsbury's merger. 73.26% of GMB members believed ASDA colleagues pay should be comparable with the £9.20 per hour paid by Sainsbury's.

In the same survey 94.18% of ASDA hourly paid colleagues believe GMB Union should be able to negotiate pay and conditions on their behalf.

When ASDA introduced Contract 6 it was £1.00 per hour above the National Living Wage (NLW). The current NLW and Contracts 1 to 5 rate of pay is £8.21 per hour.

We understand you may feel anxious and concerned. Please speak to your GMB rep or organiser. We will keep you informed as things develop and make sure you have your say.
